### ORDER

WHEREAS, Premakanthi Trust, Mangalore, Karnataka had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Sri Devi Sharada College of Education, Bhandarkars Complex, Kulur Ferry Road, Mannagudda, Mangalore-575003, Karnataka for Secondary(B.Ed) course of one year duration from the academic session 2005-06 with an annual intake of 100 students. The institution was granted recognition on 03.02.2006.

AND WHEREAS, now, the institution has submitted its written representation dated 21.01.2015 along with relevant documents received by SRC on 27.01.2015 and stated as follows:

"Kindly note that our college name has been changed from "Shri Sharada College of Education" to "Premakanthi College of Education" as per Govt. letter No.ED 165 UDA 2007 dtd. 05.12.2007 and university order No.MV/ACC/CCS/CR47/2004-05 dtd 02.02.2008. The copies of the same are enclosed herewith for your kind perusal".

AND WHEREAS, the SRC in its 279th Meeting held on 01st February, 2015 considered the matter, letter dated 21.01.2014 along with relevant documents, decided to defer till receipt of further instruction from NCTE (H'qrs) for change of name.

AND WHEREAS, NCTE-Hg has issued guidelines for processing pending application dated 18.12.2014 wherein the guideline for processing of name change cases is included. Subsequently, no further clarification is issued.

AND WHEREAS, the SRC in its 286th Meeting held on 30th April, 2015 considered the request of the change of college name and it has decided to "Process/Obtain documents as per guidelines issued by NCTE". Therefore, the institution is required to submit the following documents, a. Resolution of the Society b. NOC from the Registrar of Societies or trust c. NOC from the affiliating bodies.

AND WHEREAS, accordingly, a letter was issued to the institution on 29.05.2015. The institution has submitted a letter dated 29.06.2015 received in this office of SRC-NCTE on 03.07.2015

AND WHEREAS, the Southern Regional committee in its 290" meeting held during 10" & 11th July, 2015 considered the matter and decided that change of name of the "Sri Devi Sharada college of Education" Bhandarkars Complex, Kulur Ferry road, Mannagudda, Mangalore-575003. Karnataka to "Premakanti College of Education" is permitted subject to no change in the location of the institution, Structure/Nature of management and other usual conditions.

Further, the committee advised Southern Regional Office to Inform the University concerned.
